THOSE WORDS WERE SPOKEN BY A 7 YEAR-OLD BOY WHO WAS LIVING IN SAFEHOME'S SECURE, CONFIDENTIAL SHELTER. IN 2013, SAFEHOME PROVIDED 17,950 NIGHTS OF SAFETY FOR 282 WOMEN AND CHILDREN. SAFEHOME'S SHELTER OFFERS WRAP-AROUND SUPPORT FOR VICTIMS OF DOMESTIC VIOLENCE AND THEIR CHILDREN. SERVICES INCLUDE ALL DAILY MEALS; CLOTHING AND PERSONAL ITEMS; A PRIVATE HOTEL-LIKE ROOM, INSTEAD OF DORM ARRANGEMENTS; ACCESS TO MEDICAL SERVICES AND INDIVIDUAL ADVOCATES TO ASSIST WITH FINANCIAL, VOCATIONAL, PARENTING AND OTHER NEEDED RESOURCES. TRANSITIONAL LIVING ASSISTS FAMILIES TO SECURE AFFORDABLE LIVING ARRANGEMENTS AFTER LEAVING THE SHELTER. ALL SERVICES ARE TARGETED TO HELP RECONFIGURED FAMILIES BECOME SELF-SUFFICIENT.

SAFEHOME HAS 5 FULL-TIME, LICENSED PROFESSIONAL THERAPISTS EXPERIENCED IN WORKING WITH ADULTS AND CHILDREN TRAUMATIZED BY DOMESTIC VIOLENCE. COUNSELING IS AVAILABLE IN ENGLISH AND SPANISH. IN 2013, SAFEHOME CLINICAL STAFF AND 15 MASTERS LEVEL INTERNS SAW 1,141 ADULTS AND CHILDREN. A UNIQUE COMPONENT OF THE COUNSELING PROGRAM IS LETHALITY PREVENTION. SAFEHOME WORKS CLOSELY WITH THE DISTRICT ATTORNEY AND LOCAL LAW ENFORCEMENT TO PREVENT HOMICIDES IN DOMESTIC SITUATIONS THAT ARE EVALUATED AS POTENTIALLY LETHAL. VICTIMS AND THEIR CHILDREN RECEIVE CRISIS INTERVENTION COUNSELING AND IMMEDIATE SHELTER TO ESCAPE DANGER.

ADVOCATES AND TRAINED VOLUNTEERS RESPOND TO VICTIMS IN CRISIS WITHIN 30 MINUTES AT LOCAL HOSPITALS AND MEDICAL CLINICS. COURT ADVOCATES, TRAINED VOLUNTEERS AND THE STAFF ATTORNEY ACCOMPANY VICTIMS THROUGH THE OFTEN COMPLEX AND FRIGHTENING LEGAL RAMIFICATIONS OF DOMESTIC VIOLENCE INCIDENTS.
